They had also discussed a whole range of issues, including trade, the United States joining the Coalition for Disaster-Resilient Infrastructure, a key global initiative launched by India at the last UNGA; H-1B visas and on-going and increasing restrictions; Iran; the need for free and open Indo-Pacific and China; and the drawdown of US troops in Afghanistan.

U.S. companies are in the race for multi-billion dollar deal for 114 fighter jets, among other deals.
Interoperability of India, US Naval Ships: Tactical Data interlinking to be discussed at 2+2 Dialogue Financial Express December 10, 2019	Despite the existing Communications Compatibility and Security Agreement (COMCASA) framework for the interchange of encrypted communication between India and the US, effective joint operations using ships, submarines and aircraft shall be possible only when interoperability is achieved at the tactical level through the Tactical Data Link (TDL) of each Force. This is one of the many issues that will be discussed at the forthcoming 2+2 Indo-Us Ministerial Dialogue in Washington DC.
