ndia and France recently concluded the seventh edition of their biennial joint military exercise, "Shakti," held at a Joint Training Node in Meghalaya. The exercise, aimed to strengthen cooperation and interoperability between the armed forces of both nations, featured rigorous training scenarios across various domains.

"Shakti" emphasised tactical proficiency and strategic alignment, reflecting the strong defense partnership between India and France. This exercise not only reinforced bilateral ties but also underscored both countries' commitment to enhancing regional security and global peace through collaborative military engagements.

## **RIMPAC 2024 Commences**

Rim of the Pacific (RIMPAC) 2024 has begun in Hawaii, bringing together navies from across the globe for the world's largest maritime exercise. Hosted by the U.S. Pacific Fleet, this biennial event focuses on enhancing interoperability and readiness through a range of naval operations.

Participants will engage in maritime security drills, disaster response simulations, and complex warfighting exercises over several weeks. In addition to tactical skills, RIMPAC aims to



foster diplomatic relations and mutual understanding among nations addressing shared challenges in the Indo-Pacific region.

The exercise serves as a testing ground for new technologies and operational concepts while promoting international norms and a rules-based maritime order. RIMPAC 2024 highlights the collective commitment to global security and stability through cooperative

naval engagements.

## **Indo-Pacific Pact Signed by 14 Nations**

At the Indo-Pacific Economic Framework (IPEF) meeting, India, the U.S., and 12 other nations signed a significant economic pact focusing on supply chain resilience, clean energy, and fair economic practices.

This agreement aims to address challenges, such as climate change and economic disruptions while ensuring equitable growth. India's Commerce



Secretary emphasised the importance of collective action in fostering sustainable and inclusive economic development across the Indo-Pacific region. (ET, 10.06.24)

### Samsung Chief Meets Tech CEOs in U.S.

Samsung Electronics Chairman Lee Jaeyong held a series of meetings with the leaders of global tech giants including Meta, Amazon and Qualcomm, to strengthen ties and boost collaboration during his twoweek trip to the U.S.

During his meeting with Qualcomm CEO Cristiano Amon, Lee discussed expanding collaboration in AI chips. Samsung, which has a long-standing partnership with Qualcomm uses Qualcomm's advanced Snapdragon chips in its flagship smartphones. (TN, 14.06.24)

## **Indian Exports to Soar by 2030**

India and France have announced plans to establish a climate fund to support startups in Indo-Pacific countries. The fund aims to promote innovative solutions for climate change mitigation and adaptation in the region.

This initiative reflects the commitment of both countries to address environmental challenges and promote sustainable development in the Indo-Pacific.

#### **EU's Defence Links with Japan, S. Korea**

The European Union is pursuing security and defense industry partnerships with Japan and South Korea aimed at the joint development of military equipment. This initiative, reported by the Nikkei, would mark the EU's first security and defense-related collaboration with Asian nations.

There has been a proposal to expand opportunities for Japanese companies to participate in research and development programmes in the defense sector led by the EU, which would provide capital for joint projects between Japanese and European companies. (Observer, 23.06.24)

#### **Group of Seven Focuses on Migration**

The Group of Seven (G7) Summit, held in Southern Italy, concentrated on migration issues, seeking ways to combat trafficking and increase investment in countries where migrants begin their journeys.

Migration is a priority for host Italy and its Premier Giorgia Meloni, who aims to increase investment and funding for African nations to reduce migratory pressure on Europe. (AP, 15.06.24)

### France-Germany-Britain Condemn Iran

France, Germany and Britain have condemned Iran's latest steps to further expand its nuclear programme as reported by International Atomic Energy Agency (IAEA).

The joint statement highlighted Iran's operation of additional advanced centrifuges at Natanz and its plans to install thousands more at Natanz and Fordow, further undermining the Joint Comprehensive Plan of Action (JCPoA).

### **China Praises Ties with S. Korea-Japan**

Chinese Premier Li Qiang praised the renewed relations with Japan and South Korea during the first trilateral talks in four years.

The meeting focussed on reviving trade and security dialogues hampered by global tensions and advancing threeparty free trade agreement negotiations, stalled since 2019. (TJP, 28.05.24)

#### **U.S.-India Discuss Strategic Partnerships**

During a recent meeting between U.S. National Security Advisor Jake Sullivan and Indian National Security Advisor Ajit Doval, discussions included defense acquisitions, cooperation in space and shared concerns about China's activities.

The meeting emphasised the importance of the Quad Alliance in promoting a free and open Indo-Pacific. (TP, 17.06.24)

## Singapore, Vietnam Call for Peace Amid Drills

Amid large-scale military exercises surrounding Taiwan, Singapore and Vietnam have called for regional peace and stability. Singapore's Deputy Prime Minister Gan Kim Yong warned of the grave repercussions of a conflict in the Taiwan Strait.

In Vietnam, the government hoped Taiwan and China could maintain peace, stability, and cooperation. Peace would not only benefit the whole world, including people on both sides of the Taiwan Strait (DM, 27.05.24)

## **Philippines Reaffirms Clean Energy Goals**

t the Indo-Pacific Economic Cooperation Summit, the Philippines reiterated its commitment to clean energy, aiming to increase renewable energy capacity to 35



Energy Secretary, Raphael Lotilla, highlighted efforts to attract investments and enhance energy infrastructure, emphasising the role of international partnerships and private sector involvement. The Summit also saw discussions on regional collaboration, innovative energy solutions, and policy frameworks to foster sustainable economic growth in the Indo-Pacific region. (SQ, 17.06.24)
