### Strategic Convergence: The Third India-Japan 2+2 Ministerial Meeting

The recent meeting of the Indian and Japanese Foreign and Defence Ministers in New Delhi marks a significant development in the strategic partnership between the two democracies aimed at preserving peace, stability and rules-based international order. The decision to update the 2008 Joint Declaration on Security Cooperation reflects a growing convergence of interests in the face of a changing regional order.

The Indo-Pacific region is witnessing growth in geopolitical tensions and unilateral assertions of power raising concerns for India and Japan. The meeting reaffirmed the commitment of both nations to a rules-based international order, a veiled reference to China's disregard for international law in the South China Sea and buttressing the QUAD partnership.

This commitment to a rules-based framework is not merely rhetorical, it is a strategic necessity. For both India and Japan, navigating the complex security landscape of the Indo-Pacific requires a clear stance against any unilateral attempts to alter the status quo by force.

The meeting's strong support for ASEAN's unity and centrality, as well as the "ASEAN Outlook on the Indo-Pacific (AIOP)" underscores their recognition of Southeast Asia's important role in maintaining regional equilibrium.

Beyond defence and security, the relationship between Japan and India is being strengthened through efforts to enhance cultural and people-to-people ties. Initiatives like the establishment of India's new Consulate in Fukuoka and upcoming cultural exchange programmes reflect a comprehensive approach to their bilateral relations.

Alongside addressing security concerns, the Ministers unequivocally condemned terrorism in all its manifestations. They urged for decisive measures to dismantle terrorist networks and disrupt their support structures, underscoring their shared commitment to global peace and security.

The pow-wow reflects the growing economic ties between Japan and India and their mutual interest in diversifying supply chains. The partnership between India and Japan is strengthening, with increased defence ties, joint military exercises, and enhanced defence information sharing.

India is also participating in the Indo-Pacific Economic Framework for Prosperity (IPEF), highlighting its strategic role in the region and the expanding collaboration with Japan. Both countries value the United States as a vital partner in maintaining regional security and are not aiming to exclude any other country.

In conclusion, the Third India-Japan 2+2 Ministerial Meeting is a positive step forward for a strategic partnership that is becoming increasingly important in the Indo-Pacific region. The convergence of security and economic interests points towards a deepening relationship that will contribute to a stable and prosperous regional order.
