G7 Italia: Global Leaders Unite for a Better Future

The 50th G7 Summit, held in Italy's Apulia region, marked a significant convergence of global leaders addressing pressing international issues. The summit saw participation from the world's most advanced economies, with India's Prime Minister Narendra Modi among the invited guests, reflecting India's growing influence in global affairs. The summit's agenda was diverse, tackling climate change, economic stability, geopolitical tensions, and international health challenges.

The Italian Prime Minister Giorgia Meloni and African Development Bank President Dr Akinwumi A. Adesina announced joint initiatives under Italy's Mattei Plan for Africa, focusing on economic partnerships, energy, climate, food security, health, and employment. Italy committed substantial funding, matched by the Bank, to support impactful development and migration management. Other than this, the Group also recognised the increasing importance of the growing African continent in the global economic space, including its admission as a permanent member of the G20.

At New Delhi we organised a high-level roundtable discussion titled "Mainstreaming the African Union into the G20" in partnership with the Vivekananda International Foundation on July 1, 2024. The meeting resolved that the African Union Commission and not just India should find ways and means to integrate the African continent into the G20 and other global governance systems. Furthermore, at the G7 summit, global issues such as migration, artificial intelligence (AI), and economic security were pivotal discussions on the summit's second day. Leaders supported Ukraine, managed migration issues, and promoted gender equality.

Pope Francis made a historic appearance, urging leaders to prioritise human dignity in Al development and warning against autonomous machine decisions, especially in warfare. The G7's final statement echoed his concerns, stressing human-centred Al governance and ethical considerations.

A significant outcome was the commitment to advancing the India-Middle East-Europe Economic Corridor (IMEC), aimed at enhancing connectivity and countering China's Belt and Road Initiative. Additionally, the G7 leaders pledged to counter China's unfair practices while affirming they would not hinder Chinese growth.

Prime Minister Modi highlighted India's role in global policy and addressed the G7 Outreach Summit, calling for an end to technology monopolies and advocating for peaceful resolutions, notably in Ukraine.

Overall, the summit underscored the need for collective action and solidarity in tackling global challenges, setting a hopeful tone for future international collaboration. Alas, the issue of proper representation in the UN Security Council was not discussed, even though G7 Members like Germany and Japan are strong contenders, other than India etc for a permanent membership.

EU adopts new sanctions against Russia, including LNG

European Union countries adopted a 14th package of sanctions on Russia that aims to close some loopholes and hits Russia's gas exports for the first time, EU foreign ministers said.

Western powers imposed sweeping sanctions on Moscow after Russia launched a full-scale invasion of Ukraine in February 2022, which have been progressively ramped up since.
