Enhancing Strategic Partnerships: PM Modi's Visits to France and the US

Modi's Diplomatic Push

Indian Prime Minister Narendra Modi's visit to France and the US from February 10–13, 2025, further strengthened India's global partnerships. In France, he co-chaired the AI Action Summit and advanced cooperation on modular nuclear reactors, reflecting shared innovation goals.

In Washington, D.C., he and President Trump discussed trade, defence, and strategic ties. Key takeaways from the US include plans to double bilateral trade to \$500 billion by 2030, potential F-35 sales to India, the emergence of "COMPACT" and "TRUST", and increased energy imports to address trade imbalances. While Trump criticised India's tariffs, both leaders signalled a willingness to negotiate. The visit also touched on immigration, with Modi pledging to tackle human trafficking.
